I am writing in response to your email dated 2nd February 2021 (received into our office 3rd February) requesting information under the Freedom of Information Act (2000) regarding medication

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.
