I am writing in response to your email dated 17<sup>th</sup> July 2018 requesting information under the Freedom of Information Act (2000) regarding nurse vacancies.

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 I am writing to you under the Freedom of Information Act 2000 to request the following information regarding the recruitment of nursing and midwifery Staff:

How many FTE nurse vacancies do you currently have?

- A1 Registered Nursing and Midwifery vacancies at 31/05/2018 = 209.30 FTE Note:
  - Vacancies is calculated as Budgeted Establishment less Staff in Post
- Q2 What was your total nursing agency spend for financial year 2017/18 inclusive?
- A2 The Trust total nursing agency spend for financial year 2017/18 inclusive was £3,627k
- Q3 Had the Trust recruited nursing and midwifery staff from outside the UK during the 2017/18 financial year
- A3 The Trust has not actively recruited nursing and midwifery staff from outside the UK during the 2017/18 financial year
