I am writing in response to your email dated 5th December 2019 sent to Trust Matron requesting information under the Freedom of Information Act (2000) regarding NHS values.

On 11th December 2019 we contacted you via email for proof of identity:

The FOI Act clearly states that if we suspect that the request has come from a Pseudonym we are entitled to request proof of the person's identity, as provision of a Pseudonym invalidates a request, therefore please can you provide a photo copy of your driver's licence or other official document that validates your identity.

On 15th December 2019 (received into our office 16th December) you sent in the required identification.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- Q1 I should be grateful if you would let me know what measures are in place at your hospital to ensure that every patient is treated according to the NHS values: working together for patients, commitment to quality of care, compassion, respect and dignity, improving lives, everyone counts.
- A1 I can confirm that the Trust holds information regarding what measures are in place at your hospital to ensure that every patient is treated according to the NHS values, but feel this information is exempt under section 21: *information reasonably accessible by other means*.
