I am writing to acknowledge receipt of your email dated 23rd August 2021 requesting information under the Freedom of Information Act (2000) regarding public expenditure.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 We are writing to you under the Freedom of Information Act 2000 to request information in reference to public expenditure.

In reference to the Trusts expenditure and estate, can you please provide details of the following?

1. Identification of all construction projects (classified specifically as a refurbishment or new build) within your estate since 2010, where the project value exceeded £1m
2. Project cost (cost accuracy to the nearest £m) and the year of completion
3. Confirmation of the Trust appointed project team (organisation name only), namely:
 - a. Selected Contractor
 - b. Architect
 - c. Structural Engineer
 - d. M&E Engineer

Please provide the information in a tabular or spread sheet form as seen below:

For ease of completion, we have appended a template (populating information where known). We would ask that gaps are completed; any errors are amended and information relevant to the request be added.

We are in the process of researching and mapping the key supply side stakeholders within the healthcare construction sector, to inform an assessment of the future market capacity. We request the right to re-use your information (as part of an aggregated data set) in publication of our research.


