I am writing to acknowledge receipt of your email 15th January 2025 requesting information under the Freedom of Information Act (2000) regarding Wrong Implant/Prosthesis

On 16th January 2025 you emailed the following

I recently contacted you with a Freedom of Information request, titled "Freedom of Information Request: Wrong Implant/Prosthesis."

Please note that I would like to retract question 6, which read:

"In total, how much has the Trust paid in damages for legal claims related to wrong implant or prosthesis incidents?"

Please do not answer this question and instead provide a response for questions 1-5.

Q1 I am requesting this information under the Freedom of Information Act. Could you please provide data in response to the following questions:

Since January 1, 2020, how many incidents have been reported to your Trust involving a wrong implant or prosthesis?

Please note that this is any incident falling under the following definition: "Placement of an implant/prosthesis different from that specified in the procedural plan, either before or during the procedure. The incident is detected any time after the implant/prosthesis is placed in the patient." For each incident, please provide the month, year and the implant or prosthesis involved in the procedure.

- Q2 In addition, please confirm the total number of cases reported between January 1, 2020, and December 31, 2024.
