Q1 Under the Freedom of Information Act 2000, please can you disclose the following information:

In the past three years, how many patients aged 65 and above attended/were admitted to a hospital apart of the Trust with health problems related to cold temperatures, such as chest infections, respiratory conditions, flu, hypothermia and others? (Broken down by years: 2022, 2023, 2024)

A1 The Trust has collated the following information based on your clarification received 7th January 2024.

On 7th January 2025 we contacted you via email with the following.

To continue with your request we require clarification on the following:

question 1 - In the past three years, how many patients aged 65 and above attended/were admitted to a hospital apart of the Trust with health problems related to cold temperatures, such as chest infections, respiratory conditions, flu, hypothermia and others? (Broken down by years: 2022, 2023, 2024) —

Firstly, the conditions are too vague. We need you to be more specific as we do not group conditions into categories. Please can you give a more definitive group of conditions. Also, we need them to clarify are you just after people who attended our ED department and/or people who attended outpatient appointments for the stated conditions. You also mention "health problems related to cold temperatures" are we just looking at specific months? If so, what are these months or is it just all attendances for the stated conditions no matter what time of year it is?

On the same day you replied with.

'Apologies, could you please provide figures for attendances from August to December for 2022, 2023 and 2024.

As for the conditions could you please provide figures for Influenza and pneumonia (ICD10 Codes: J09-J18), Acute bronchitis (J20), Bronchitis, not specified as acute or chronic (J40) and Emphysema (J43).'
