I am writing in response to your email dated 4th June 2019 requesting information under the Freedom of Information Act (2000) regarding stop smoking services.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 Request 1:

Please confirm or deny if you are currently, or have been in any year since 2015-16, commissioned to provide stop smoking services

If confirm, please provide your allocated budget for

- a) this financial year (2019-20)
- b) each of the previous years to 2015-16 that you have been commissioned to deliver the service

If deny, please confirm or deny if you have access to an on-site stop smoking service

A1 We are not commissioned to provide stop smoking services. However the Royal University Hospital have access to services on site by a provider commissioned by Public Health Stoke. We have no inpatient service at County Hospital.

A2 Please see below:

i) Therapies included on the North Staffordshire Joint Formulary are Second line: Bupropion hydrochloride as part of a smoking cessation programme only if NRT ineffective, not tolerated or inappropriate.

Second line: Varenicline (Champix®) as part of a smoking cessation programme only if NRT ineffective, not tolerated or inappropriate.

- ii) First line: Nicotine replacement therapy as part of a smoking cessation programme or during inpatient stay only.
- iii) The main form of treatment received by patients is NRT Patches and PRN NRT Lozenges/gums for craving

Q3 Request 3:

Please confirm or deny if you have on-site shops selling:

- a) Licensed nicotine-replacement therapies,
- b) Unlicensed quitting aids
- c) e-cigarettes
- A3 These products are not permitted to be sold on Trust premises, however Lloyds Pharmacy provide for outpatient prescriptions and they can supply if required.

Please confirm or deny if you have policies in place to implement NICE guideline PH48, Smoking: acute, maternity and mental health services, with regards to recommendations for:

- a. Ensuring immediate access to stop smoking pharmacotherapies and a range of licensed nicotine-replacement therapies for patients who smoke
- b. Ensuring the sale of stop smoking pharmacotherapies and licensed nicotinereplacement therapies in hospital shops
- c. Ensuring care pathways deliver continuity between hospital and primary care stop smoking services (including any referral pathways)
- d. Encouraging patients using unlicensed quitting aids to switch to licensed quitting aids
