I am writing to acknowledge receipt of your email dated 5th March 2024 requesting information under the Freedom of Information Act (2000) regarding guidelines

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- Q1 The subject is surrounding scaphoid fracture, so I am emailing to request if possible, the current guidelines/policy on the management of these fractures either when referred from ED or other areas to fracture clinic.
- A1 The Department has a "T & O Guidelines" document which details Scaphoid fracture management. Adapted extract below:

If a fracture is visible on initial x-rays, Clinician decides on conservative vs operative treatment. Indications to proceed to surgery:

• Displaced Fracture (waist and proximal pole), DISI deformity, Perilunate dislocation, Consider occupation and other associated injuries & non-unions.

If surgical management is required/appropriate discuss and refer to Hand Surgeons If Non-union organise a CT

Conservative:

- Below elbow cast for 6 weeks (not scaphoid cast)
- Review at 6 weeks for clinical review and x-ray
- If no pain + signs of healing, mobilise and review in 6 weeks & Xray
- If painful and no signs of healing consider cast for further 2 weeks

• If at 8 weeks, still painful and no signs healing then CT scan and discuss with hand surgeons

For query scaphoid fractures where x-rays are normal but clinically painful scaphoid examination – a CT scan will be performed (scaphoid long axis). If CT negative, then discharge patient with open appointment. If positive, then treat as above.
