I am writing to acknowledge receipt of your email dated 10th June 2022 requesting information under the Freedom of Information Act (2000) regarding Junior Doctors.

The University Hospitals of North Midlands Trust is committed to the Freedom of Information Act 2000.

However, the NHS is facing unprecedented challenges relating to the coronavirus (COVID-19) pandemic at the current time. Understandably, our resources have been diverted to support our front-line colleagues who are working tremendously hard to provide care for our patients, and to those in need of our services.

We strive to be transparent and to work with an open culture. But at this time, whilst care of our patients and the safety of our staff takes precedent, it is likely that responses to some requests for information will be delayed. We apologise for this position in advance, and will endeavour to provide you with as much information as we can, as soon as we are able.

The Information Commissioners Office has recognised the current situation in the NHS.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 Junior Doctors

Please would you provide me with the following information concerning the use of temporary, locum or bank staff for the duties performed by Junior Doctors?

- **The number of shifts worked by temporary/locum/bank staff.**
- **The cost of this temporary/locum/bank staff**

Please provide the figures:

- **For each of the years 2017, 2018, 2019, 2020, 2021.**
- **For each hospital in the Trust**
- **By Specialty.**
- **For each staff grade.**

My organisation has developed a system that helps reduce spend on locums and I need to determine the potential savings.

A1 See below: note,

- Agency data prior to 2018 is not held due to a change in provider
- The Medical Bank system commenced from 2018

I can neither confirm nor deny whether the information you have requested is held by the Trust in its entirety. This is because the information requested in at Specialty level is not held centrally, but may be recorded in individual report records (48 reports X 5 years). In order to confirm whether this information is held we would therefore have to individually access all individual report records within the Trust and extract the information where it is present. We therefore estimate that complying with your request is exempt under section 12 of the FOI Act: *cost of compliance is excessive*. The section 12 exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all individual report records and then extracting relevant information would take longer than the 18 hours allowed for. In addition to the section 12 exemption the Trust is also applying section 14 (1) exemption: *oppressive burden on the authority*

Under section 16 of the FOI Act we are required to provide requestors with advice and assistance where possible. We would therefore like to advise you that your request has been shortened to what we can provide. In order to avoid delay to your response we have provided this below.

We have been able to provide the total data for the Trust as follows. Data is not split between hospitals in the Trust


