 - c) The maximum hourly rate or session rate for such payments for the 2023-24 financial year (if providing by session please state length of session (in hours).

We are unable to answer the question regarding the weekend and evening work as the financial ledger doesn't break down the data to that extent. for weekend and evening work:

We would be required to extrapolate information from the system and extract all the information and including Strike Spreadsheets (approximately 92 spreadsheets and over 5000 lines) and create a new report to provide this. Consultant Rate Card

In hours (0700-1900) £150/hr (UHNM Rate card + 30%) for those doing additional sessions or time shifting SPA

OOH on site (1900-0700) £229/hr (UHNM Rate card + 100%)

Non-resident on call - £919.60 for the on-call shift and the £229 per hour for additional hours worked after the first 2 hours. (UHNM Rate card + 100%)

This applies for all Consultant and Independent SAS Doctors and is applicable to all departments.
