- Q2 Finally could you advise how these are recorded so they can be coded by the Clinical Coding Team, do you use an electronic system with a specific code or do you manually record these in the patient notes?
- A2 At UHMN the CRIS imaging system uses NICIP exam codes which map to SNOMEDCT codes, not OPCS.
