I am writing to acknowledge receipt of your email dated 19<sup>th</sup> April 2021 requesting information under the Freedom of Information Act (2000) regarding Covid-19

## The University Hospitals of North Midlands Trust is committed to the Freedom of Information Act 2000.

However, the NHS is facing unprecedented challenges relating to the coronavirus (COVID-19) pandemic at the current time. Understandably, our resources have been diverted to support our front-line colleagues who are working tremendously hard to provide care for our patients, and to those in need of our services.

We strive to be transparent and to work with an open culture. But at this time, whilst care of our patients and the safety of our staff takes precedent, it is likely that responses to some requests for information will be delayed. We apologise for this position in advance, and will endeavour to provide you with as much information as we can, as soon as we are able.

#### The Information Commissioners Office has recognised the current situation in the NHS

I can neither confirm nor deny whether the information you have requested is held by the Trust in its entirety. This is because the information requested in your question is not held centrally, but may be recorded in individual health/death records. In order to confirm whether this information is held we would therefore have to individually access all individual health/death records within the Trust and extract the information where it is present. We therefore estimate that complying with your request is exempt under section 12 of the FOI Act: *cost of compliance is excessive*. The section 12 exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all individual health/death records and then extracting relevant information would take longer than the 18 hours allowed for. In addition to the section 12 exemption the Trust is also applying section 14 (1) exemption: *oppressive burden on the authority* 

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 1. I would like to know how many people have died in your hospitals solely from covid 19? The figures online are of deaths within 28 days of a positive test, but this means that the patients could have died of anything. I would like to know how many people you can attribute no other possible causes of death to, this would suggest they died of







#### nothing but covid-19.

#### Essentially how many perfectly healthy people have died with nothing other than covid-19.

### I would like the deaths counted from the dates February 1st 2020 to the present (Or the most recent data you have)

A1 Section 12 and 14 exemptions as detailed above, however note:

- Q2 The percentage & number of people with 'underlying health conditions in the overall total.
- A2 As answer 1
- Q3 The percentage & number of those with 'underlying health problems.
- A3 As answer 1
- Q4 If possible I would like to know how many people have died within 28 days of having a covid-19 vaccine administered; this can be from any of the vaccine manufacturers. Although I would prefer it split up by vaccine manufacturer and the total number of vaccines administered from each manufacturer.

Essentially I would like to know how many people died within 28 days of being administered; this should include both the first and 2nd dose (if the person has received the 2nd dose).







A4 Information note held, note: The Trust mainly vaccinated NHS staff and this is not a community hub therefore the GP may be able to advise further.
