I am writing to acknowledge receipt of your email dated 14th October 2021 requesting information under the Freedom of Information Act (2000) regarding Mechanical Restraint.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 Does the NHS Trust authorise the use of any kind of mechanical restraint?

- A1 No
- Q2 What types of Mechanical Restraint is authorised? e.g. Handcuffs; Soft Cuffs; Velcro Leg restraints; Emergency Response Belts (ERB). Spit hoods
- A2 Not applicable
- Q3 Is the necessary training to apply the authorised form of mechanical restraint linked to a nationally recognised training qualification?
- A3 As answer 2
- Q4 Does the NHS Trust authorise the use of Posey Mitts, if a risk assessment deems them to be a reasonable and proportionate response?
