I am writing to acknowledge receipt of your email dated 26th February 2024 and 8<sup>th</sup> March 2024requesting information under the Freedom of Information Act (2000) regarding Unconscious bias training and land owned.

We replied via email with the following:

UHNM has received several requests that are asking for information that are from the same person/company, therefore we are contacting you to inform you that under section 12 of the FOI Act we were aggregating these requests on land/ Unconscious bias training.

Your new reference number for both requests is 845-2324.

The section 12 exemption states:

The authority can combine related requests received within a period of 60 consecutive days from: • The same person or

• People who appear to be acting in concert or in pursuance of a campaign.

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.
