- I am currently in year 3 of my nursing degree at Keele. We have an assignment to propose a new innovation or adapt a current one. Mine is creating an in-person simulation focusing on delirium in ICU. To improve nurse's competency and knowledge, to have a positive impact within practice. I am inquiring into what is the current training in place for delirium specifically in ICU for the nurses at UHNM.
- A1 Critical Care nurses receive delirium education in a variety of forms including:

Classroom based.

New starter induction programme [8 weeks supernumerary period with associated study days].

In-house Step 1 Critical Care program.

Practice/bedside:

Practical assessments and application of Pain, Agitation, Delirium and Sleep clinical guidelines delivered to all nurses by PDN, clinical mentors and Rehab Coordination teams to support completion of CC3N Step 1,2 & 3 competency requirements.

Adhoc teaching sessions to support MDT education and increase awareness [i.e. World Delirium Awareness Day].

Online resources:

New clinical Pain, Agitation, Delirium and Sleep guidelines with associated teaching videos. Resources embedded within electronic documentation system and on Trust Intranet.
