I am writing in response to your email dated 15<sup>th</sup> August 2018 requesting information under the Freedom of Information Act (2000) regarding charitable funds.

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- Q1 Would you please let me have my Freedom of Information request for the names and 2017/18 incomes of the top 5 funds within the UHNM NHS Trust Charity
- A1 I can confirm that the Trust holds information regarding charitable funds, but feel this information is exempt under section 22: *Information for future publication and section 40(2):* personal information. As to release names would breach the Trusts obligations under the Data Protection Act 2018

Some of this information will be included in the UHNM Charity Accounts and Annual Report 2017/18. The audited accounts for 2017/18 will not be available until after the Charitable Funds meeting on 23rd November 2018. The accounts are being prepared for audit in October. Following the meeting in November, the Annual report and accounts, which lists the top funds by income and expenditure, will be published.

Please note the annual report will list the top (by value) 1: donors, but an individual will not be named and initials will be used and a company is listed only if permission is given (so some may be missing) 2: fundraising activities by activity name and not individual or company name; and 3: legacies by value anonymously using initials. These lists are 'top' to the whole charity (i.e. all funds) and not to specific funds.
