I am writing to acknowledge receipt of your email dated 1st March 2024 requesting information under the Freedom of Information Act (2000) regarding Endometriosis

On 4<sup>th</sup> March 2024 we contacted you via email with the following: To continue with your request we require clarification on the following:

On the same day you replied via email with:

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- Q1 The number of women who have been diagnosed with Endometriosis between 2019 to 2023 (i.e. 2019, 2020, 2021, 2022, 2023)
- A1 I can neither confirm nor deny whether the information you have requested is held by the Trust in its entirety. This is because the information requested in this question is not held centrally, but may be recorded in health records (We do not record on Careflow patient's medical conditions therefore we are unable to identify patients who have been "diagnosed). In order to confirm whether this information is held we would therefore have to individually access all health records within the Trust and extract the information where it is present. We therefore







estimate that complying with your request is exempt under section 12 of the FOI Act: *cost of compliance is excessive*. The section 12 exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all health records and then extracting relevant information would take longer than the 18 hours allowed for. In addition to the section 12 exemption the Trust is also applying section 14 (1) exemption: *oppressive burden on the authority*

- A3 Following the clarification, as the question relates to endometriosis referrals we do not record the reason for the referral therefore we are unable to state how many "endometriosis referrals" we have received.
- Q4 The number of female patients awaiting a referral appointment (i.e. are still on the waiting list) for any hospital/specialist centre (whichever is applicable) under your NHS Trust for gynaecological care.







To avoid confusion, please specify for each category the exact number of female patients with endometriosis if the figure is less than 5 (i.e. avoid saying 1-5 and please state if the figure is 1, 2, 3, 4, or 5.)

A4 Following the clarification, as the question relates to endometriosis referrals we do not record the reason for the referral therefore we are unable to state how many "endometriosis referrals" we have received.
