I am writing in response to your email dated 1st October 2019 requesting information under the Freedom of Information Act (2000) regarding high-risk maintenance backlog.

On 2nd October 2019 we contacted you via email as we required the following clarification: What specific 2 year date range the applicant requires i.e. Do you wish the date range to extend two years back from the date of your FOI request or are you referring to financial /calendar years? if so, which?

In addition:

Could you please confirm that where you request copies of RIDDOR reports of "dangerous incidents" what you actually mean and require are copies of RIDDOR reports of "reportable dangerous occurrences"?

On 3rd October 2019 you replied via email with the following: *"The two years from today please. And yes I'm after copies of the riddor reports."*

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- Q1 A breakdown of the high-risk maintenance backlog, as of the most recent Estates and Returns Information Collection submission.
- A1 I can confirm that the Trust holds information regarding the above, but feel this information is exempt under section 21: information reasonably accessible by other means. This is because the information is available via NHS Digital's public website at the following link:

- Q3 A copy of all reports made to the HSE under RIDDOR in the last two years relating to accidents and dangerous incidents caused by buildings, vehicles and equipment
- A3 Please refer to the attached documents. Some information within the letters has been redacted. This is because it is exempt under section 40(2) of the FOI Act: *personal information*. The information could be used to identify individual staff/patients and/or their representative and therefore has not been released.

This exemption is an absolute exemption and therefore no consideration of the public interest test is needed.

- Q4 Details of how many times in the last two years the Trust has:
 - Experienced a leaking roof in an area where patients are present and details of any incidents;
 - Experienced a broken or leaking sewage pipe in an area where patients are present and details of any incidents;
 - Contracted a pest control service and details of any incidents.
