I am writing to acknowledge receipt of your email dated 13th May 2024 requesting information under the Freedom of Information Act (2000) regarding General Ward Monitoring

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- Q1 We would like to place a Freedom of Information request, wishing to obtain an Install Base report for Monitoring systems within general wards at your NHS hospitals. We are specifically looking for the following information.
  - Hospital Name
  - Hospital Postcode
  - General ward monitoring OEM
  - Model
  - Installation date (Please provide year of installation, where various please provide number installed within each specific year)
  - How many beds in your general ward
  - Is your general ward monitor connected to an EPR
  - Who is your EPR supplier

## **System Definitions:**

- EPR An electronic patient/health record is a digital version of a patient's paper chart
- OEM original equipment manufacturer e.g. Philips
- General Ward monitoring A general ward monitor also known as a vital signs monitor or a spot check monitor is typically used to track a patients vital signs and overall wellbeing sporadically. A few examples of such include Philips EarlyVue VS30, Mindray VS900 and GE Portratin VSM.
