## Dear

I am writing in response to your email dated 22<sup>nd</sup> December 2020 requesting information under the Freedom of Information Act (2000) regarding Equipment.

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- Q1 How many CT scanners do you have in your Trust?
- A1 Six (6)
- Q2 How many of these CT scanners are over 10 years old?
- A2 None
- Q3 How many MRI scanners do you have in your Trust?
- A3 Seven (7)
- Q4 How many of these MRI scanners are over 10 years old?
- A4 None
- Q5 Is your Trust a member of an imaging or pathology network/alliance?
- A5 See below:
  - Imaging no
  - Pathology yes
- Q6 Has your Trust been working in partnership with a community health setting offering diagnostics services (i.e. a dedicated diagnostic service not part of a Trust or GP practice, such as a community diagnostic hub)?
- A6 No
- Q7 What proportion of your pathology diagnostic equipment is over 10 years old?







- A7 34% of the capitally purchased pathology diagnostic equipment is >10 years old. Some equipment in Microbiology / Virology and Histology is part of two managed service contracts as such is not capitalised. All the equipment included in the Managed Service Contract is <10 years old.
- Q8 What are the daily running and on-going maintenance costs of the cardiorespiratory diagnostic facilities in your Trust?
- A8 The annual maintenance costs are £23061, Daily running costs as follows:
  - Respiratory Physiology £2215.47
  - Sleep Physiology £6039.38
- Q9 What were the installation costs of the cardiorespiratory diagnostic facilities in your Trust?
- A9 Information not held
- Q10 What proportion of your genomics equipment is over 10 years old?
- A10 Not applicable as UHNM does not perform genomic testing on site.
- Q11 Is your Trust working in collaboration with a genomics laboratory hub?
- A11 We refer specimens for genomic analysis to the West Midlands regional genomics centre.
- Q12 If the answer to (11) was 'Yes', what proportion of total genomics diagnostic procedures that your Trust is responsible for are allocated to the genomics hub
- A12 100% of genomics referral specimen are sent to the West Midlands regional genomics centre
