I am writing in response to your email dated 1st July 2019 (received into our office 2nd July) requesting information under the Freedom of Information Act (2000) regarding Sterile Services.

On 2nd July 2019 we contacted you via email as we required clarification on question 1, what did you mean by a surgical admission, did you mean admissions that actually have a procedure undertaken or patients admitted under a surgical specialty?

On 3rd July 2019 you replied via email the following:

'Thanks for your response. We want to know the number of surgical admissions which actually have a procedure undertaken. Sorry for the misunderstanding.'

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 The requested information is for years 2012/13-2017/18 on the following questions:

How many surgical admissions occur each year?

A1 Please see below: note your clarification-"We want to know the number of surgical admissions which actually have a procedure undertaken". Therefore the following information shows the number of admissions where there is OPCS clinical coding added to the record. We have taken the assumption these are "surgical admissions" as per clarification.
