I am writing to acknowledge receipt of your email dated 3rd February 2022 requesting information under the Freedom of Information Act (2000) regarding Covid.

The University Hospitals of North Midlands Trust is committed to the Freedom of Information Act 2000.

However, the NHS is facing unprecedented challenges relating to the coronavirus (COVID-19) pandemic at the current time. Understandably, our resources have been diverted to support our front-line colleagues who are working tremendously hard to provide care for our patients, and to those in need of our services.

We strive to be transparent and to work with an open culture. But at this time, whilst care of our patients and the safety of our staff takes precedent, it is likely that responses to some requests for information will be delayed. We apologise for this position in advance, and will endeavour to provide you with as much information as we can, as soon as we are able.

The Information Commissioners Office has recognised the current situation in the NHS.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 I would like to ascertain the following:

1. How many patients does the Trust currently have in hospital with Covid 19 (by this I mean people taking a bed?)

A1 See below:

Q2 How many of these have been vaccinated with either one, two or three doses, and how many have had no jabs at all.

Q4 How many in the ICU being treated for Covid are vaccinated (by this I mean one, two or three jabs), and how many have had none at all?

Q5 How many of those in the ICU are there being treated for Covid ONLY as opposed to Covid as an incidental thing alongside something else

A snapshot of one day would be good, so I will ask for the 1st of February 2022.

I would also like the figures for the same five points for the 1st of January 2022, the 1st of December 2021, and the 1st of November 2021.

A5 We are unable to provide the information you require in the requested format as to release this data could lead to the identification of the person(s) involved due to the low numbers involved, and would breach the Trusts obligations under Data Protection Act 2018. Accordingly, this aspect of your request is exempt from disclosure under the terms of Section 40(2) of the FOI Act. *Personal information*. However as the Trust is committed to openness and transparency we can band the numbers as being <5

This exemption is an absolute exemption and therefore no consideration of the public interest test is needed.
