## Dear

I am writing to acknowledge receipt of your email dated 16th July 2021 requesting information under the Freedom of Information Act (2000) regarding oesophageal and gastric cancer.

I can neither confirm nor deny whether the information you have requested is held by the Trust in its entirety. This is because the information requested in partial question 2 is not held centrally, but may be recorded in individual health records. In order to confirm whether this information is held we would therefore have to individually access all health records within the Trust and extract the information where it is present. We therefore estimate that complying with your request is exempt under section 12 of the FOI Act: cost of compliance is excessive. The section 12 exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all health records and then extracting relevant information would take longer than the 18 hours allowed for. In addition to the section 12 exemption the Trust is also applying section 14 (1) exemption: oppressive burden on the authority

Under section 16 of the FOI Act we are required to provide requestors with advice and assistance where possible. We would therefore like to advise you that if your request is shortened to just the questions that we are able to comply within the 18 hour time frame. In order to avoid delay to your response we have provided this below.

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- Q1 I am researching the incidence and treatment of oesophageal and gastric cancer. I would greatly appreciate if you could answer the following questions.
  - Q1. Does your Trust treat the following conditions?
    - Advanced oesophageal cancer
    - Advanced gastric cancer
    - In case you do not treat either of the above conditions, which other Trust do you refer these patients to?

Oesophageal cancer (any type) = 67 first treatments for patients with an oesophageal (ICD-10 code C15) primary cancer over the period January to June 2021

- Oesophageal adenocarcinoma = 50
- Oesophageal squamous cell carcinoma = 7
- Unresectable oesophageal squamous cell carcinoma = <5 out of 7 patients received surgery as first treatment
- Gastric cancer (any type) = Unsure what ICD-10 diagnosis codes to include
- HER2 negative or HER2 untested gastric cancer = Section 12 exemption as detailed above
