About how you report the carbon footprint of your medicines to assist us in developing solutions to support the NHS Net Zero strategy. This is a request under the Freedom of Information Act 2000.

The questions below relate to **medicines carbon footprint reporting for your Trust**.

**Question 1:** Do you calculate the carbon footprint of medicines?

**Answer 1:** No as its regional data that we use, it's not actually UHNM that calculates it.

**Question 2:** What was the carbon footprint of medicines for 2021?

**Answer 2:** 2677 tonnes CO<sub>2</sub>e (or other units - please specify)

*Above comprises data for Nitrous Oxide & Entonox 2020/21 – 2356 tCO<sub>2</sub>e & Volatile Gas (Desflurane, Sevoflurane, Isoflurane) 2020/21 – 321.23 tCO<sub>2</sub>e*

*Inhalers (data only available at Regional ICS Level) 2020/21 – 944,419 ktCO<sub>2</sub>e*

**Question 3:** How did you calculate the carbon footprint of medicines in 2021?

We did not use this methodology. We are requesting investment from the Trust to undergo a carbon foot-printing exercise across all Scopes 1, 2 & 3 emissions; this will provide UHNM with a Carbon Dashboard and also align our data collection and reporting with our peers. The outputs will provide a more robust baseline data set in which carbon reduction information can be reported and will also establish the on-going procedures for the longevity of carbon footprint reporting beyond the baseline.
