## Q1 I am aware that your organisation funds specialist menopause clinics in Secondary Care.

- 1. Please could you inform me how often these clinics run,
- 2. how many hours are provided
- 3. how many clinicians attend each clinic.

## A1

- 1. We have four menopause clinics. One clinic consists of 5 clinic slots and runs weekly. One clinic consists of 1 slot and runs alternate weeks. Another clinic runs every fourth week and consists of 4 clinic slots and one clinic runs alternate weeks and consists of 2 clinic slots.
- 2. Each clinic appointment slot is allocated 30 minutes.
- 3. One Clinician attends each clinic.
