I am writing to acknowledge receipt of your email dated 6th December 2023 requesting information under the Freedom of Information Act (2000) regarding waiting list.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

I am writing to make an open government request for all the information to which I am entitled under the Freedom of Information Act 2000. I would like the following information please.

The number of patients who have died while on your NHS waiting list and therefore have been removed from that list due to their death or status as being deceased.

I would like this complete data broken down into the years 2018, 2019, 2020, 2021, 2022 and the year 2023 to date (December).

If possible, I would also like a breakdown of age for every patient who died while on your NHS waiting list please.

I am aware a similar request was submitted some time ago but I am looking for updated data for 2023 and a breakdown of the other years also. I am noting this as I didn't want to be redirected to older, previous data. I am also aware that you cannot provide the reason for death.

<u>Please note:</u> As UHNM is a significantly sized organisation our lists are much larger than others and therefore the number of deaths would be greater; also, that their death may not be in relation to the condition they are on the waiting list to be treated for

A1 The below table is the unique number of patients removed from either an elective waiting list or from a closed referral with a reason of Patient Died. Note: This relates to all patients who died prior to being admitted to hospital and were removed from the waiting list. It is **not** related to in hospital deaths.
