I am writing in response to your email dated 25th February 2019 requesting information under the Freedom of Information Act (2000) regarding LIMS (Laboratory Information Management System).

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 Under the freedom of information act please could you answer the following questions around your Trust's LIMS (Laboratory Information Management System?)

Do you have a full User Requirement Specification (URS) within your LIMS service?

- A1 UHNM does not hold a URS in relation the LIMS
- Q2 Do you have a full (requirements) traceability matrix (RTM) to drive validation for LIMS
- A2 UHNM Pathology work with UKAS (accreditation) to ensure validation of the LIMS is achieved.
- Q3 Do you have full validation evidence ready for review and fully referenced on your local QMS for LIMS?
- A3 Yes
- Q4 Which LIMS is in use?
- A4 Clinisys LabCentre is the LIMS used by UHNM Pathology services
- Q5 When was it last upgraded?
- A5 March 2017
- Q6 When was the URS last reviewed?
- A6 UHNM does not hold a URS in relation the LIMS
- Q7 When did the MHRA last inspect the lab?
- A7 Please see below:







- RSUH = April 2009
- County = March 2012

Q8 How much notice did MHRA provide before this inspection?

A8 County hospital was inspected under Mid Staffordshire Foundation Trust (MSFT) prior to the acquisition of the Trust (UHNM). We do not have any evidence available regarding notice provided for this visit.

RSUH – Information not held, however, MHRA have always been able to attend the site without any notice. Although we are usually given two weeks' notice to ensure that the appropriate person(s) would be available.

- Q9 Would you benefit from a review of evidence to assess the transfusion labs "readiness for inspection"?
- A9 The FOI Act 2000 is for the release of information that is held/recorded and does not cover the opinions of persons regarding suppliers, systems or procedures, therefore this information is not held.
