I am writing to acknowledge receipt of your email dated 13th July 2022 requesting information under the Freedom of Information Act (2000) regarding non-tuberculosis mycobacterium

The University Hospitals of North Midlands Trust is committed to the Freedom of Information Act 2000.

However, the NHS is facing unprecedented challenges relating to the coronavirus (COVID-19) pandemic at the current time. Understandably, our resources have been diverted to support our front-line colleagues who are working tremendously hard to provide care for our patients, and to those in need of our services.

We strive to be transparent and to work with an open culture. But at this time, whilst care of our patients and the safety of our staff takes precedent, it is likely that responses to some requests for information will be delayed. We apologise for this position in advance, and will endeavour to provide you with as much information as we can, as soon as we are able.

The Information Commissioners Office has recognised the current situation in the NHS.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- Q1 How many patients were treated in the last 12 months (for any disease) with:
 - a) Ethambutol + rifampicin + Clarithromycin/azithromycin
 - b) Ethambutol + rifampicin + Clarithromycin/azithromycin with the addition of injectable (IV) or nebulised Amikacin
- We are unable to provide the information you require in the requested format as to release this data could lead to the identification of the person(s) involved due to the low numbers involved, and would breach the Trusts obligations under Data Protection Act 2018. Accordingly, this aspect of your request is exempt from disclosure under the terms of Section 40(2) of the FOI Act. *Personal information*. However as the Trust is committed to openness and transparency we can band the numbers as being <5







This exemption is an absolute exemption and therefore no consideration of the public interest test is needed.

- a) Ethambutol + rifampicin + Clarithromycin/azithromycin =<5
- b) Ethambutol + rifampicin + Clarithromycin/azithromycin with the addition of injectable (IV) or nebulised Amikacin = 0
- Q2 How many patients have been diagnosed in the last 12 months for the following diseases?
 - a) Non-tuberculosis mycobacterium (NTM) (ICD10 codes: A31.0/A31.9)
 - b) Bronchiectasis (ICD10 codes J47/Q33.4)
- We are only able to advise the number of patients who have been an inpatient in the Trust and have the above clinical coding applied to their Careflow inpatient record.

If a patient was diagnosed as having these conditions during an outpatient attendance we are unable to advise the numbers diagnosed as diagnosis information is not recorded on the Careflow OP attendance.

Non-tuberculosis mycobacterium (NTM) (ICD10 codes: A31.0/A31.9)

We have looked at the number of IP records during the period 1st June 21 to 31st June 22 whose ICD10 clinical coding contains either A31.0 or A31.9.

As the request is after the number of patients we have shown the number of unique patients, so if a patient was admitted multiple times during the period we would only count the patient once.

There are **10 unique patients** during this period who have the ICD10 coding A31.0/A31.9 on their inpatient record.

Bronchiectasis (ICD10 codes J47/Q33.4)

We have looked at the number of IP records during the period 1st June 21 to 31st June 22 whose ICD10 clinical coding contains either J47 or Q33.4.

As the request is after the number of patients we have shown the number of unique patients, so if a patient was admitted multiple times during the period we would only count the patient once.

There are **988 unique patients** during this period who have the ICD10 coding J47/Q33.4 on their inpatient record

- Q3 Which other hospital trust or health care professional would you contact if you require advice on non-tuberculosis mycobacterium (NTM) infections?
- A3 Fellow clinicians on ID team (3 x Consultants), Consultant respiratory physician with special interest in TB (UHNM) and the national MDRTB clinician forum (virtual MDT on email / Teams) of which UHNM ID team are members, also Consultant Pharmacists at TB centres specialising in MDRTB. These apply to NTM infections too.
- Q4 Do you discuss difficult to manage non-tuberculosis mycobacterium (NTM) patients as a Multidisciplinary Team (MDT)?







A4 Yes, however it depends on the nature of resistance, some cases do not warrant MDT approach after initial treatment plan agreed
