I am writing in response to your email dated 31st May 2019 requesting information under the Freedom of Information Act (2000) regarding guidelines.

The Trust considers some of your request (b, c, d, and e) to be exempt from disclosure in accordance with section 43(2) of the Freedom of Information Act as to release this information would, or would be likely to, prejudice the commercial interests of the Trust. The Trust has applied the public interest test to this request and feels that the public interest in maintaining the exemption outweighs the public interest in disclosure.

On 7th June 2019 you emailed us with additional questions to your request.

We replied the same day via email advising you that the timeline for a response would be adjusted accordingly.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

In `addition` to these can I also request the following please: The Intensive Care / Critical Care clinical guidelines that were in place from 5th December 2018 to 12th December 2018 inclusive please and the Intensive /Critical Care clinical guidelines that are currently in place whilst `the current guidelines are being updated `please	Please see attached document, please note: that this is the Intensive Care/Critical care guidelines at UHNM in place prior to those that are being updated (for adult patients). These will also be the guidelines in place from 5th December 2018 till 12th December 2018. Please also note that these guidelines covered Hyponatremia and Sodium disorders in a specific subgroup of patients with "acute severe traumatic head injury." For management of Hyponatremia for the rest of the medical patients the Trust medical guidelines will still be followed. This will be the case for current management of patients as well whilst critical care guidelines are updated. For conditions other than Hyponatremia in critical care we would follow national and international guidelines for specific conditions. (Intensive care society UK, European society of intensive care, NICE etc.)
