I am writing to acknowledge receipt of your email dated 4th October 2021 requesting information under the Freedom of Information Act (2000) regarding CAMHS.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 My name is Josie Canham-Williams, and I am currently compiling statistics for a research project being conducted by Jacqueline Thomas QC and Ashley Lord of Counsel focusing on the mental health and secure estate available to vulnerable young people across England, Wales, and Scotland. The purpose of the research project is to better understand the wider picture so far as provision of mental health and secure beds are concerned across those three jurisdictions and follows decisions in a concerning number of court cases identifying a lack of appropriate provision. With that in mind, I make the below request for information under the Freedom of Information Act: Please could you kindly provide details of?

1. The number of low secure Children and Adolescent Mental Health Service (CAMHS) and medium secure CAMHS beds within your Authority or Trust and how many of those are currently available for new admissions.

A1 UHNM does not hold secure mental health beds

Q2 The number of low secure CAMHS beds within your Authority or Trust and how many of those are currently available for new admissions.

A2 UHNM does not hold secure mental health beds

Q3 The number of medium secure CAMHS Service beds within your Authority or Trust and how many of those are currently available for new admissions.

A3 UHNM does not hold secure mental health beds

Q4 The number of welfare social care secure beds within your Authority or Trust and how many of those are currently available for new admissions; and

A4 UHNM does not hold secure mental health beds

Q5 The number of forensic secure beds within your Authority or Trust and how many of those are currently available for new admissions.

A5 UHNM does not hold secure mental health/ forensic secure beds

Q6 Further, please could you kindly provide details of:

The number of young people within your Authority area or Trust area who have been assessed as requiring a CAMHS Tier 4 mental health bed but have not been admitted due to a shortage in resource (we do not require personal details or reasons for the conclusion reached, just numbers).

A6 I can neither confirm nor deny whether the information you have requested is held by the Trust in its entirety. This is because the information requested in this question is not held centrally, but may be recorded in individual health records. In order to confirm whether this information is held we would therefore have to individually access all health records within the Trust and extract the information where it is present. We therefore estimate that complying with your request is exempt under section 12 of the FOI Act: *cost of compliance is excessive*. The section 12 exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all health records and then extracting relevant information would take longer than the 18 hours allowed for. In addition to the section 12 exemption the Trust is also applying section 14 (1) exemption: *oppressive burden on the authority*

Under section 16 of the FOI Act we are required to provide requestors with advice and assistance where possible.
