I am writing to acknowledge receipt of your letter dated 29th January 2025 requesting information under the Freedom of Information Act (2000) regarding to sitting rooms

Q1 I am writing under the freedom of information act to find out the answers to the following question.

Does your Trust provide any dedicated facilities such as but not limited to sitting rooms, restaurant areas or car parking for medical consultants or non-training doctors.

All Doctors can access dedicated rest facilities at both County Hospital and Royal Stoke University Hospital. These are not located within a restaurant and the facilities within vary but provide seating at both table and sofa level as well as desk facilities/kitchenette. All other rest facilities are communal for all UHNM staff members. There is no dedicated parking for Doctors/Consultants in place.

UHNM values all UHNM employees in their equally weighted value in service contribution and so there is no beneficial treatment issued to any singular staff group.
