I am writing in response to your email dated 7th August 2019 requesting information under the Freedom of Information Act (2000) regarding Nursing Agency Usage.

UHNM responded to this FOI request on 17th July 2019 on Reference 166-1920 this request is identical. In accordance with Section 14 (2) of the FOI Act, Where a public authority has previously complied with a request for information which was made by any person, it is not obliged to comply with a subsequent identical or substantially similar request from that person unless a reasonable interval has elapsed between compliance with the previous request and the making of the current request.

This exemption is an absolute exemption and therefore no consideration of the public interest test is needed.

- Q6 Based on the above information, who are your current Nursing Off-Framework agencies and how many shifts have been booked for each month from January 2019 June 2019.
