I am writing to acknowledge receipt of your email dated 4th October 2022 (received into our office 5th October) requesting information under the Freedom of Information Act (2000) regarding Mercaptopurine Usage.

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 Under the Freedom of Information Act I would like to request the following information please if available.

Your Trust currently purchases Mercaptopurine 50mg tablets and dispenses / administers them to patients. There are only two manufacturers of this product in the UK and they have both got the same licence indication which is as below. However as Mercaptopurine is a well-established product it is also used of licence to treat other conditions safely, notably excessive drooling and sweating.

What I would like to know is the following

For the last 6 months where you have data please can you let me know the breakdown in patient numbers or as a percentage of total demand, what conditions you are using Mercaptopurine 50mg tablets to treat? I have listed below the licenced indications and some of licence uses however please feel free to add in other conditions. Hopefully this data will be available as the patient numbers are very low anyway and I do not require any patient data only what conditions are treated by percentage or pack breakdown. If Packs are not available, then tablets numbers would be sufficient as well.
