Describe the role or team responsible for procurement:	The supplies and procurement department consists of approximately 119 staff split across three sites, Royal Stoke and County Hospital and New Cross Hospital (Wolverhampton), and divided into 4 broad teams; • Procurement Systems Services Primarily maintains and manages the procurement related purchase to pay system. • Capital Procurement Team Purchase all the capital funded equipment for the trust, whether via direct tenders or utilising frameworks, and consist of a senior manager, contract manager and capital buyer. • Operational Procurement and Supply Chain Management Low level procurement, which are all purchases for a broad range of goods and services for the whole Trust under the value of £20,000, are conducted by the Operational Procurement Team, consisting of assistant buyers and supervisors. There are also Materials Management roles which focus more on NHS Supply Chain related purchases. • Strategic Procurement Higher value purchases and contracts. The Strategic Procurement team has designated contract managers and buyers for the various divisions within the Trust and each manage a portfolio of contracts for their area, reviewing each and tendering for a range of products and services, or accessing various frameworks. The team consists of a number of Strategic Managers, Contract Managers and Buyers.
Describe the diversity and inclusion training or guidance they receive:	Each member of staff is required to undertake the mandatory Trust Equality and Diversity Training and 3 yearly refresher. Those with line management responsibilities will be, as it is deemed essential to role training to undertake the Gateway to Management, which includes prerequisite elearning on equality and diversity in recruitment e-learning package.
