I am writing to acknowledge receipt of your email dated 11th September 2024 requesting information under the Freedom of Information Act (2000) regarding maternity

- Q1 I would like to know, for each year from 2021-2023 inclusive, [whether calendar or financial, depending on how these figures are collected], please provide the total number of women who used maternity services at your Trust (to include antenatal care, labour and birth, and post-natal care.)
- A1 Volumes indicate all Maternity system documented activity where patient has either 'Booked' or antenatal care (irrespective of birth outcome), Delivery event, or Postnatal care note figures may include patients suffering from miscarriages, out of area patients (where we're not the lead provider) and those who may have delivered at another Trust.

There may be an overlap as this includes activity where either Antenatal care booked, delivered or post-natal care provided is logged within the time period and counted against the latest care date (therefore a patient 'booked' in 2020 but delivered or Postnatal during 2021 will be counted in 2021)

Patients accessing all aspects of care will be counted ONLY ONCE – by the 'latest' aspect of care provided.
