I am writing in response to your email dated 22nd October 2018 requesting information under the Freedom of Information Act (2000) regarding accommodation provision.

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- Q1 Do you provide an accommodation service to employees and new starters?
- A1 UHNM Trust provides access to a small portfolio of Residential Accommodation
- Q2 If answer is yes to Q1 please provide how many rooms you have available to staff
- At County Hospital (Stafford) we have access to 126 single rooms, at the Royal Stoke University Hospital we only have family accommodation.
- Q3 How much do you charge per night for short lets, and how much per month for longer lets?
- A3 Please see below:
  - County short lets (less than one month) = £27.50 per night
  - Royal Stoke and County (Longer Lets) Price range £407 to £685 per month
- Q4 Do you have any packages in place for new starters to the organisation in regards to accommodation? If so, please provide details
- A4 Short-term accommodation is provided for up to a maximum of one month, for those employees taking up new appointments whilst they seek private accommodation. (Depending on if accommodation is available at the time of requesting)
- Q5 Do you work in partnership with other organisations to provide an accommodation service? le. Housing association
- A5 No
