I am writing in response to your email dated 15th May 2018 requesting information under the Freedom of Information Act (2000) regarding local authority staff.

I can neither confirm nor deny whether the information you have requested is held by the Trust in its entirety. This is because the information requested in question 1 is not held centrally, but may be recorded in individual departmental records. In order to confirm whether this information is held we would therefore have to individually access all departmental records within the Trust and extract the information where it is present. We therefore estimate that complying with your request is exempt under section 12 of the FOI Act: *cost of compliance is excessive*. The section 12 exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all departmental records and then extracting relevant information would take longer than the 18 hours allowed for.

Under section 16 of the FOI Act we are required to provide requestors with advice and assistance where possible. We would therefore like to advise you that if your request is shortened to just questions 2 and 3 we are able to comply within the 18 hour time frame. In order to avoid delay to your response we have provided this below.

On 16th May 2018 we contacted you via email as we required clarification on the time frame for this information.

On 17th May 2018 you replied via email the following: "Please could you provide the data from 2010 to present? Apologies for the omission."

On 11th June 2018 we contacted you via email as we required clarification on Q3 and whether you meant ALL patients discharged from the hospital for just information on patients discharged by the local authority?

On 18th June 2018 you replied via email the following:

"All patients please."



As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- Q1 Could you please provide the following information relating to discharge teams in your Trust: Firstly, how many members of staff are employed full time or part time within your hospital discharge team?
- A1 Information not held prior to merger in November 2014. Information for 2014 onwards Section 12 exemption as detailed above.
- Q2 Secondly, how many local authority staff are employed by your Trust to facilitate discharge into adult social care?
- A2 Information not held by the Trust however, Midlands Partnership NHS Foundation Trust may hold this and they can be contacted at the following email: foi@mpft.nhs.uk
- Q3 Thirdly, could you please provide all available data on how many patients you discharge broken down annually and by month if possible.
