Q1 Please could you answer the below questions in relation to Nursing on framework supply;

Please can you confirm how many shifts have been released/allocated to ON framework agencies within the last 90 days?

- A1 3206 this covers the period of 1st March 2024 to 30th May 2024.
- Q2 In the last 90 days which wards, or departments were these ON framework requests for?
- A2 Total of 52 wards across medicine, surgery, women's & children's and specialised services.

This covers the period of 1st March 2024 to 30th May 2024.

- Q3 Please can you confirm how many nursing shifts have been filled by ON framework agencies within the last 90 days?
- A3 2808 this covers the period of 1st March 2024 to 30th May 2024.
- Q4 How many long term lines of work or block bookings are currently being supplied by ON framework agencies?
- A4 46 since 1/4/24
- Q5 Which ON framework agencies is the trust currently utilising for Nursing vacancies and what is the spend on these agencies year to date?

- A7 The average is about £32.00 per hour
- Q8 Who at Temporary Staffing is responsible for onboarding new agencies and could you provide their email address and contact number?



- A8 Onboarding is completed by the ward staff where agency is allocated
- Q9 What is the generic Nurse bank email address for staff bank?
