I am writing in response to your email dated 6<sup>th</sup> September 2018 requesting information under the Freedom of Information Act (2000) regarding the former Royal Infirmary Site.

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

## Q1 Under the Freedom Information Act may I ask for the following information?

### Q2 Asbestos - Royal Infirmary Site

Confirmation that the Trust has in place a detailed and current Asbestos Management Plan as required under the Control of Asbestos Regulations 2012 which is based upon a risk assessment following completion of both a management and Refurbishment/Demolition surveys







A2 The Trust adheres to the Control of Asbestos Regulations 2012 (CAR 2012) and has an asbestos management plan in place. As per regulations a survey is undertaken whenever refurbishment or demolition works take place.
