## Dear

I am writing in response to your email dated 8<sup>th</sup> March 2019 requesting information under the Freedom of Information Act (2000) regarding additional questions on cladding from FOI reference 693-1819.

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

## Q1 Please can you give me more detail on the type of cladding used i.e. the brand used, what type of aluminium etc?

A1 At UHNM the following type of cladding is used:

County Hospital (Stafford)— Promisol Panels manufactured by Haironville TAC. A bi modular composite cladding consisting of:

2 galvanised skins, factory bonded with a polyurethane foam core.

## RSUH - Various types

- Rainscreen cladding Protens aluminium AME rainscreen with an aluminium honeycomb manufactured by AME Facades LTD. 70mm Kingspan, K15 insulation within 0.7mm CH47 profile horizontally laid sheet and composite
- Rainscreen cladding Protens aluminium AME rainscreen with an aluminium honeycomb manufactured by AME Facades LTD.
- Metal cladding Kingspan KS900 & KS1000 Optimo external wall cladding.
- Louvre Architectural Profiles AP70LCP Aluminium Louvre Cladding
- Kingspan KS 1000 EB vertically laid panels
- Protens HR Metal AME rainscreen with an aluminium honeycomb manufactured by AME Facades LTD.
- Rainscreen bespoke 3mm folded aluminium manufactured by Colt International
