I am writing to acknowledge receipt of your letter dated 27th January 2025 requesting information under the Freedom of Information Act (2000) regarding talc pleurodesis procedure

- Q1 I am requesting the records that shows how many people have had talc pleurodesis procedure within the last 4 years.
- A1 The total of talc pleurodesis procedures was 150 procedures over the last 4 years.
- Q2 What the conditions the patients had and how long they lived after this procedure. I'm interested in people who had asthma, COPD, anxiety and metastatic lung cancer stage 4, also CKD
- As we do not record co-morbidities on our Clinical Information System, we are unable to identify the cohort of patients mentioned in the question. Unfortunately, we do not hold the reason why a person died and if a procedure contributed to extending the life of a person. This level of information is not recorded on the Clinical Information System and can only be obtained by manually reviewing patients notes. Section 12 exemption as detailed below.

I can neither confirm nor deny whether the information you have requested is held by the Trust in its entirety. This is because the information requested in this question is not held centrally but may be recorded in health/death records (150 patient records). In order to confirm whether this information is held we would therefore have to individually access all health records within the Trust and extract the information where it is present. We therefore estimate that complying with your request is exempt under section 12 of the FOI Act: cost of compliance is excessive. The section 12 exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all health records and then extracting relevant information would take longer than the 18 hours allowed for. In addition to the section 12 exemption the Trust is also applying section 14 (1) exemption: oppressive burden on the authority
