I am writing to acknowledge receipt of your email dated 11th October 2022(received into our office 12th October) requesting information under the Freedom of Information Act (2000) regarding Employee Statistics.

On 24th October 2022 we contacted you via email as we required the following clarification: What do you mean by 'When the Keele Medical School relocated onsite'?

On 25th October 2022 you replied via email with:

'I was enquiring about the Keele Medical School and when it was first established on the Royal Stoke site- was it located somewhere else before the Royal Stoke site or has it always been part of the site?'

On 9th November you emailed us with the following:

'I am writing to enquire about the data I have asked for. As your previous response states, by law, you should have replied by the 8th of November.

Kindly let me know when you will reply by.'

Please note that whilst your request was awaiting clarification the 'clock stops' therefore the 20 working day deadline is amended to 11th November 2022

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 I am writing to request the following pieces of information about the Royal Stoke University Hospital:

How many people were employed by the North Staffordshire Royal Infirmary before services were transferred to the Royal Stoke Hospital?

A1 The headcount and FTE of staff employed by the former University Hospital of North Staffordshire NHS Trust as at 31st October 2014 was:

As of 1st November 2014 Royal Stoke University Hospital and County Hospital (Stafford) became known as University Hospitals of North Midlands NHS Trust (UHNM). Prior to this the site now known as County Hospital (Stafford) and managed by UHNM, was known as and managed by Mid Staffordshire Foundation NHS Trust (MSFT)

A8 The Keele University Medical School was established in 2002/2003. The first students graduated in 2005. The School consisted of 2 educational buildings at RSUH. The Integrated Clinical Education Centre and the Undergraduate Medical School building(known as UGMS1) Around 2005 a third building was erected on the Keele University site(known as UGMS2).
