## Dear

I am writing in response to your email dated 1<sup>st</sup> August 2018 regarding our response to your request for information under the Freedom of Information Act (2000) regarding homeless patients. (Please see our original response attached)



You contacted us via email with the following query:

"Currently you're the only Trust in the country suggesting they do not hold this information centrally. Could you confirm why? I will have to make that clear in my research and piece".

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 Under the Freedom of Information Act I wish to request the following information.

The number of patients presenting at your A&E/urgent care centres whose address is recorded as no fixed abode or any other similar indicator the Trust uses to categorise those who do not have a fixed address/are homeless.

- A1 Following your query regarding our original response, the Trust re-ran the data and can confirm that we have identified 984 patients from this timeframe that have either NFA, or No Fixed Abode recorded against their address. We apologise for any inconvenience our original response may have caused.
- Q2 The number of patients admitted into your hospital/s whose address is recorded as above

Please provide these figures for each financial year from 2010/11 to the 2017-18.

- A2 Please see below:
  - A&E = 622
  - Inpatient = 361
