I am writing in response to your email dated 26th June 2019 requesting information under the Freedom of Information Act (2000) regarding Shunts (CSF Diversion).

I can neither confirm nor deny whether the information you have requested is held by the Trust in its entirety. This is because the information requested in your questions is not held centrally, but may be recorded in individual health records. In order to confirm whether this information is held we would therefore have to individually access all health records within the Trust and extract the information where it is present. We therefore estimate that complying with your request is exempt under section 12 of the FOI Act: *cost of compliance is excessive*. The section 12 exemption applies when it is estimated a request will take in excess of 18 hours to complete. We estimate that accessing and reviewing all health records and then extracting relevant information would take longer than the 18 hours allowed for.

In addition to the section 12 exemption the Trust is also applying section 14 (1) exemption: *oppressive burden on the authority*

Under section 16 of the FOI Act we are required to provide requestors with advice and assistance where possible. We would therefore like to advise you that if your request is shortened to just the total number of shunts preformed we are able to comply within the 18 hour time frame. In order to avoid delay to your response we have provided this below.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- Q1 We would like to request your Trust figures in terms of numbers of shunts (CSF Diversion) which maybe ventricular peritoneal shunt, lumboperitoneal shunt or any other form of CSF diversion in addition to the number of venous sinus stents performed for the diagnosis of idiopathic intracranial hypertension in 2018.
- A1 Using the coding supplied by the Clinical Coding Team (see below for the list) for 2018 the total number of shunts performed is 146, however we are unable to advise the reason for why the shunt was performed, sections 12 and 14 exemptions as detailed above.
