I am writing to acknowledge receipt of your email dated 29th August 2024 requesting information under the Freedom of Information Act (2000) regarding Occupational Health Services

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

Q1 I am writing to you with a Freedom of Information request regarding Occupational Health (OH) Services within your Trust. We would like to get the following data relating to OH Services :

Does your NHS Trust provide its employees (doctors, nurses, other clinical staff) with Occupational Health (OH) Services? (Yes/No)

- A3 See above A2: This is all outsourced and is paid on a contract, so therefore a split between physical and mental health services would not be possible.
- Q4 Does the Trust provide these services in-house, or does it outsource it through a contract?







a. Please provide the split of the percentage of in-house vs outsourced services based on the values provided in Question 2 (i.e., how much is spent on OH services in-house vs contracting to outsourced providers) for the last 3 years (FY 2021/22, 2022/23, 2023/24)?
