I am writing to acknowledge receipt of your email dated 29th July 2022 requesting information under the Freedom of Information Act (2000) regarding cable ties.

**The University Hospitals of North Midlands Trust is committed to the Freedom of Information Act 2000.**

**However, the NHS is facing unprecedented challenges relating to the coronavirus (COVID-19) pandemic at the current time. Understandably, our resources have been diverted to support our front-line colleagues who are working tremendously hard to provide care for our patients, and to those in need of our services.**

**We strive to be transparent and to work with an open culture. But at this time, whilst care of our patients and the safety of our staff takes precedent, it is likely that responses to some requests for information will be delayed. We apologise for this position in advance, and will endeavour to provide you with as much information as we can, as soon as we are able.**

**The Information Commissioners Office has recognised the current situation in the NHS.**

On the same day we contacted you via email as we required clarification on whether this is a sales pitch or an actual FOI request? If a request, then please supply a timeframe in order for us to collate the information, if a sale pitch please with draw this request

You replied via email with:  
*'It is a foi request? We are just wording if differently to access all the info , and Leo advise the Trusts of all the options available'*

We responded via email with:  
Thank you, however we also asked for a time frame

You replied via email with:  
*'We are ,asking if the Trust currently uses ties , if so what size of tie , colour , quantity per annum currently used , and the print they currently have to determine a quote if and when asked , because all Trusts use different ties and have different prints on them'*

We responded with: To clarify, are you asking for this year, or last year?

You replied with:



*'I am asking for the lastly year'*

As of 1<sup>st</sup> November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

**Q1 Can you advise if the Trust uses plain or printed cable ties for their waste? If the answer is no, would the Trust consider using them, if the price is right for the Trust?**

**Also we would like to let the Trust know we currently supply around 65% of the NHS, and within the next 18 months the cable ties will be fully biodegradable from SPK promotions, but currently we only use and supply nylon PA66, would this be of interest?**

A1 Cable ties are not used, nor would we look to use them with our current waste suppliers

**Q2 Can you advise the size of cable tie, the colour, and quantity per annum and print required?**

A2 Not applicable

**Q3 Can you advise if you are currently under contract if so, when is the end date?**

A3 Not applicable

**Q4 Can you advise the person or departments contact details, who deals with these and orders them?**

A4 Not applicable

**Q5 Can you advise the price per thousand of these which the Trust would like to pay to keep their consumable prices down, not what they pay already?**

A5 Not applicable

**Q6 Would the Trust like to see samples from SPK promotions? Free of charge; if yes please advise a contact dept. or person and a full postal address.**

A6 Yes, happy to receive samples, though please note that under our existing waste suppliers, cable ties are not required. Due to the sustainability drive for the Trust, I would recommend sending biodegradable only


