I am writing in response to your email dated 10th February 2021 requesting information under the Freedom of Information Act (2000) regarding equipment.

As of 1st November 2014 University Hospitals of North Midlands NHS Trust (UHNM) manages two hospital sites – Royal Stoke University Hospital, and County Hospital (Stafford). Therefore the response below is for the two sites combined from that date where appropriate.

- Q1 When are your current Vitreoretinal (VR) and Phaco equipment, and associated consumables contracts, due to expire?
- A1 The contracts are currently in place until 30th June 2021.
- Q2 Do you plan to use a national framework for the renewal of this contract? If so which one?
- A2 The Trust is currently sourcing suitable frameworks, with SBS, H.T.E and NHS Supply Chain.
- Q3 Will you plan to use capital or revenue budget to fund the next contract for Phaco and VR equipment, i.e. capital purchase or consumables based agreement?
- A3 There is currently a plan to purchase replacement equipment in the financial year of 21-22 with Capital funding, but this is not guaranteed
- Q4 How many procedures per year (Phaco and VR) will be included within the next contract award, and for how many years?
- A4 19/20 = 2,052 Phacos and 232 Vitrectomy PPV
- Q5 Do you plan to trial potential new suppliers in the next twelve months (March 2021-Feb 2022)? If so when do you expect evaluations to take place?
- A5 When the Trust can operate as BAU, trials are planned for this equipment. This is not yet scheduled due to current restrictions







Q6 Who is the procurement manager responsible for this contract?

- A6 Elizabeth Bailey Consumable items only
- Q7 Who is the clinical lead for ophthalmology?
- A7 Annie Joseph
- Q8 What was the total spend on:
 - a) phaco
 - b) VR packs in 2019?
- A8 See below:
 - Phacoemulsification Consumables Between £150,000 and £160,000
 - VR Packs Between £90,000 and £100,000
