I am writing in response to your email dated 25th September 2024 requesting information under the Freedom of Information Act (2000) regarding Single Tender Waivers.

- Q1 We would be grateful if you could provide the following information in relation to Single Tender Waivers (STW) relating to you organisation for the 2023/24 financial year please:
 - Value and volumes of STW both absolute number and percentage as a of turnover for the financial year 2023/24 (between 1st April 2023 and 31st March 2024).
- A1 There were 163 waivers for the time period with expenditure £12,221.003.00. information is not held for the percentage of turnover.
- Q2 Number and percentage of retrospective STW for the financial year 2023/24 (between1st April 2023 and 31st March 2024).
- A2 There were 53 retrospective STW which equates to 32.5%.
- Q3 Reason code (including name of reason code e.g single supplier etc) split by number and percentage of STW for the financial year 2023/24 (1st April 2023 and 31st March 2024)
